

Privacy Policy

Protecting your private information is our priority. This Privacy Policy governs data collection and usage of the products, services, software, platform and websites (collectively, “Services”) provided by Tampa Contractor Group and any of our affiliates (collectively, “Tampa Contractor Group”). By using the Services, you consent to the data practices described in this policy. If you do not agree to any part of this Privacy Policy, then you should stop accessing the Services.

1. Collection of your Personal Information

Tampa Contractor Group may collect personally identifiable information, such as your e-mail address, name, physical address or telephone number. Tampa Contractor Group may also collect anonymous demographic information, which is not unique to you, such as your Postal Code, age, gender, preferences, interests and favorites.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through the Services, this information may be collected and used by others. Tampa Contractor Group encourages you to review the privacy statements of websites you choose to link to from our website so that you can understand how those websites collect, use and share your information. Tampa Contractor Group is not responsible for the privacy statements or other content on websites outside of the websites we operate

2. Use of your Personal Information

Tampa Contractor Group takes care of the information provided by its customers, and does not sell, rent or lease its customer information to third parties. The contact information provided to Tampa Contractor Group is not shared for marketing purposes when it comes to SMS. Tampa Contractor Group solely uses this information to contact its customers in response to services requested. Tampa Contractor Group may share data with trusted partners to help us perform statistical analysis, send you email or postal mail or provide customer support. Tampa Contractor Group keeps track of the pages our customers visit within our websites in order to determine what Services are the most popular. This data is used to deliver customized content and advertising within the websites we operate to users whose behavior indicates that they are interested in a particular subject area.

Tampa Contractor Group uses tracking pixels to collect information that helps us provide our Service to you. Please note that any “do not track” signals sent by your web browser or other mechanism have no effect on the collection of personally identifiable information by Tampa Contractor Group. In addition, other parties who perform data analytics for Tampa Contractor Group, such as Google Analytics, may collect personally identifiable information about your online activities when you use our Services. Third party affiliates of Tampa Contractor Group may have different policies with respect to “do not track” signals and Tampa Contractor Group makes no representations with respect to such policies. Tampa Contractor Group uses tracking to create remarketing audiences of users based on user behavior/their visits to our website. Tampa Contractor Group may also target these users with custom ads based on affinities/interests, geographic and demographic signals.

Tampa Contractor Group only shares browser-level data through third party vendor tracking such as Google Analytics. Users can opt out of these advertising features by visiting Google or resources like the NAI consumer opt-out page. Tampa Contractor Group may use email addresses to target users with custom ads through 3rd party advertising platforms. Tampa Contractor Group shares customer information with third parties to perform services (advertising) on our behalf.

Tampa Contractor Group may disclose personal information when we are required to or we believe it is appropriate to comply with the law (e.g., a lawful subpoena, warrant or court order); to enforce or apply this Privacy Policy or our other policies or agreements; to initiate, render, bill, and collect for amounts owed to us; to protect our or our users' rights, property or safety; to protect our users from fraudulent, abusive, or unlawful use of the Services; or if we believe that an emergency involving the danger of death or serious physical injury to any person requires or justifies disclosure of personal information.

Information about our customers, including personal information, may be disclosed as part of any merger, acquisition, debt financing, sale of company assets, as well as in the event of an insolvency, bankruptcy or receivership in which personal information could be transferred to third parties as one of Tampa Contractor Group business assets. In such an event, we will attempt to notify you before your personal information is transferred, but you may not have the right to opt out of any such transfer.

3. Use of Cookies

Our website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Services.

5. Security of your Personal Information

Tampa Contractor Group secures your personal information from unauthorized access, use or disclosure. In addition, Tampa Contractor Group secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure.
